

**Legal Entity of Public Law-Batumi Shota Rustaveli State University****Order №01-02/145****Batumi****13 November, 2020****On the measures for the Health and Accident Insurance for the International BSU Students without Citizenship of Georgia in the territory of Georgia**

Pursuant to Law of Georgia on “Higher Education, Chapter 22, Article 1, Chapter 13 of the BSU Statute, Resolution N06-01/44 of 6 August 2020 of the BSU Academic Council on “Approving the BSU 2020-2021 Academic Calendar”, **Decree №322, 23 May 2020 of the Government of Georgia on “Approving the Isolation and Quarantine Rules”**, Resolution N06-01/59 of 9 September 2020 of the BSU Academic Council on “Organized Implementation of the 2020-2021 Academic Year at the One-cycle Educational Program (instructed in English) of the Medical Doctor at BSU”, **Decree N572 of 10 September 2020 of the Georgian Government on “Defining the Terms and Rule for Health an Accident Insurance for the International Students without Georgian Citizenship in the Territory of Georgia”**, the Correspondence of the Ministry of Education, Science, Culture and Sport of Georgia MES 0 20 0000811689 of 10 September 2020 and the Correspondence -MES 5 20 0001075357-of 6 November 2020

**It was decided:**

1. To take the below given measures for the health and accident insurance for the international and without citizenship of Georgia vocational students/students (**later referred to as “the BSU student”**) of the vocational and higher educational programs of BSU while entering Georgia (or being in Georgia):
  - 1.1. **Exclude from the BSU study process and suspend the student status** ( relevant faculty has to present the office report) for the International BSU students without citizenship of Georgia who do not have the relevant health and accident insurance policy relevant to the conditions approved by the Decree N 572 of 10 September 2020 of the Georgian Government (on “Defining the Terms and Rule of the Health and Accident Insurance for the International Students without Citizenship of Georgia

in the Territory of Georgia-later referred to as “the Rule”); validity period of the **insurance policy shall not be less than one semester;**

- 1.2. The BSU students, through the BSU official web-site (including the English page) and other electronic services, shall be informed that they are obliged to have their health and accident insured at any stage of their studies pursuant to the conditions defined by the Rule approved by the Decree N 572 of 10 September 2020. The BSU student insurance policy shall cover the insurance cases (“costs of medical service and repatriation incurred by the sudden illness or an accident during the operation of the insurance policy”) meeting the insurance limits defined by Chapter 4 of the present Rule;
- 1.3. The BSU students who are in the territory of Georgia during the fall semester 2020-2021 or planned to come to Georgia in the same semester, shall be informed that they are obliged to upload the copy of the insurance policy defined in the present order on **the official web-site of the BSU –[info@bsu.edu.ge](mailto:info@bsu.edu.ge)– by no later than 20 November 2020;**
2. The order shall be uploaded on the BSU web-site;
3. The order shall be submitted to the Rector Deputies, Administration Head, the BSU Vocational Educational Programs Management and Continues Learning Centre, Financial-Economic Department, Legal Department, Nana Mazmishvili, IT Service, Study Process Department and the Students’ Career Development, Culture and Sports Department;
4. The order may be appealed to the Batumi City Court within one month of its issuance (Batumi, Zubalashvili Str. №30);
5. The Order enters into force immediately upon issuance.
